I hereby agree to indemnify and hold harmless Unmistaken Stars Farm Sanctuary, its employees, owners and agents from any and all claims, or claims by any member of my family or any other person accompanying me to Unmistaken Stars Farm Sanctuary, or while on the grounds, or the surrounding area thereto as a result of any action by any animal or person.

I acknowledge and accept that animal activities, including but not limited to the care and handling of horses, pigs, dogs, goats, etc. involve the risk of personal injury or death. By my signature, I hereby waive all rights, if any, claims, causes of actions and lawsuits against Unmistaken Stars Farm Sanctuary, Andria Iadonisi, and heirs, executors, legal representatives, administrators, successors, assigns, guests, employees, or agents affiliated with any of them in any manner, for any injury, liability, or damages which may be caused by any animal or person. I agree to indemnify and hold harmless all aforementioned entities for any accident, injury or loss that might occur, and free such persons from all liability, for such injury or loss. I understand that animals are unpredictable and I assume all risk.

No contact with animals or entrance to animal stalls, enclosures, or gated areas is permitted without express permission and direct supervision of an Unmistaken Stars Farm Sanctuary representative.

No animals are to be brought onto the grounds of Unmistaken Stars Farm Sanctuary without expressed written permission of an Unmistaken Stars Farm Sanctuary representative.

MA State Law Regarding Equine Participants

Under Massachusetts law, an equine professional is not liable for an injury to, or the death of, participant in equine activities resulting from the inherent risks of equine activities, pursuant to section 2D of chapter 128 of the General Laws.

Abuse and mistreatment of animals

Unmistaken Stars Farm Sanctuary is an abuse-free zone for both animals and humans. Please understand that USFS is a MA mandated reporter, and if deemed necessary, is required by law to report any and all assumptions of child abuse and neglect. Furthermore, any person found abusing or mistreating an animal under the care of Unmistaken Stars Farm Sanctuary will be reported to the state. Abuse is considered excessive use of force, purposely maiming or injuring an animal, and/or withholding food or water. Any person found abusing an animal will also be held responsible for said animal's medical bills stemming from such abuse. My signature below constitutes acceptance of the above terms and conditions.
